

Information Sheet TLIF0020 Safely access the rail corridor



Rail Industry Worker (RIW) Induction

This training is required for persons seeking a Rail Industry Worker (RIW) card for rail work in the Transport for NSW (TfNSW) Realm (Sydney Trains, NSW Trains, Sydney Metro, TfNSW Projects)

TLIF0020 is a national unit of competency developed to meet the applicable rail safety requirements including acts and regulations from the applicable state or territory together with any nationally approved compliance codes and/or guidelines.

JMDR are licensed by Transport for NSW to deliver this induction training package which includes specific training and assessment aligned to working in the Transport for NSW Realm. **Please note:** Other jurisdictions may require alternate or additional training/inductions to gain the required RIW card role for work.

Learning Outcomes:

On successful completion of this course, participants will:

- Gain an understanding of rail terminology (including safe place and danger zone), potential hazards in the rail corridor, basic signalling indications, rules and regulations for people accessing the rail corridor, electrical safety, personal & legal requirements of fatigue, drugs, and alcohol
- Receive a Statement of Attainment for:

TLIF0020 Safely access the rail corridor

Requirement for attending Training:

Learners will be required to display adequate core skills of being able to learn, read, write, and take part in oral communication and numeracy.

To attend training, you must:

- Provide a USI (Unique Student Identifier). Ref: usi.gov.au)
- Provide a government issued form of photo identification
- Have confirmed enrolment details
- Meet any requirements set out in the enrolment confirmation

Location: The training is conducted at our training rooms in the Sydney CBD; at Level 3, 263 Clarence St, Sydney, NSW 2000. **We are close to Town Train station**.

Training includes face to face learning, demonstration, and discussion. Training and Assessment is delivered using TfNSW courseware aligned TfNSW rules, regulations and other requirements.

Assessment

Learning and assessment activities will be conducted by our trainer/assessor using a range of evidence gathering techniques throughout the course, including written and practical demonstrations. Assessment includes both written theory (short answer, multiple choice, true/false) and practical observation assessments. You must achieve a satisfactory result in each to receive a Statement of Attainment for the nationally endorsed competency TLIF0020 Safely access the rail corridor.

Fees and Enrolment:

The course fee is **\$225 inc. GST, or \$485 inc. GST with same day Category 3 Medical.** The course fee includes workbook and assessment material. Participants must provide payment, a **completed enrolment form, agree to our terms and conditions and provide a valid USI number** before training commences.

Additional costs apply for an RIW card application.

Please note – The following requirements apply for work in the rail corridor:

- A worker must hold a current RIW card with a role applicable to the specific rail jurisdiction.
- Workers may only enter the Danger Zone, if supervised and authorised by a qualified Protection Officer.
- Any work activity must be assessed before it is commenced within the Rail Corridor by a qualified Protection Officer to determine whether it may require entry to the Danger Zone.
- Any specific industrial and jurisdiction requirements for work in the rail corridor.

Upon successful completion of training, **applicants must arrange** with an employer/registered organisation to apply for (or add this competency to) a Rail Industry Worker (RIW card). This will require a:

- A Category 3 medical certificate which is current for a period of 5 (five) years issued by a Medical Practitioner authorised by RIW.

- A 100-point id check
- A Statement of Attainment for TLIF0020 Safely access the rail corridor.

Please note: The cost for issue of an RIW card (and annual subscription) is additional to the course fee and payable to the RIW card provider (refer <u>www.riw.net.au</u>).
